

## Expression of Interest (EOI) to Participate in Tuna CHART 2025: Atlantic bluefin tuna scientific sport catch, tag and release fishery

Each applicant for a Section 14 authorisation (Fisheries (Consolidation) Act 1959) to target, catch, tag and release bluefin tuna off the Irish coast in 2025 must fill in the form below as fully as possible.

Please note the following:

- The EOI has two parts. Table1 lists minimum criteria for qualifying vessels and applicants and Table 2 lists the qualifying angling and tagging criteria. Applicants will only be considered if their vessel satisfies all criteria in Table 1 and if they agree to the conditions.
- Copies of all supporting documents must be submitted with this application.
- Mandatory attendance at a training course will be required for all prospective Bluefin tuna Section 14 holders.
- Fitting and operation of a simple vessel monitoring system (VMS) for the duration of the scientific sport catch-and-release fishery will be a requirement of the authorisation. The authorised skipper will be obliged to pay a monthly VMS fee (circa €50/month)
- A Section 14 authorisation will only be issued following training and satisfactory final boat and gear inspection. Verification of boat and equipment will be carried out by local IFI fisheries officers at the boat port by prior arrangement. Failure to have any of the required documentation or equipment will result on the non-issuing of the authorisation.
- An authorisation will be awarded to the applying **skipper**, as this is the person who will be responsible for good handling of the bluefin tuna and data recording and reporting. The authorised skipper MUST be on board every bluefin tuna angling trip.
- It is envisaged that authorisations will be awarded on a proportional basis, based on the distribution of eligible applicants and to provide broad spatial coverage around the coastline.
